Approval of April 27, 2003 minutes: Dave Shafer noted the following changes to the minutes of the April 27, 2003 meeting. Page 3, under New Business, Audit Committee: The first sentence should read, "An audit of the records of the Missouri Federation treasurers Bob and Loretta Welch, Doin 's advertising records of Dave and Dee Shafer, Doin s circulation records of Charles and Dorthy Ball, and License Plate coordinator records of Linda Collins was conducted. Dallas Wheeler made a motion to accept the minutes of the April 27, 2003, meeting as corrected. Motion carried.

Treasurer's Report: J.W. & Jan England. J.W. reported that a beginning balance on April 27, 2003: \$15,699.24; April income: \$3,430.73; April expenses: \$228.94; May income: \$13.10; May expenses: \$3,344.48; Balance on hand May 31, 2003: \$15,569.65; CD Investments: \$17,000.00; Total funds available: \$32,569.65. The treasurer's report was filed for audit.

# **Committee Reports**

Membership: J.W. & Jan England. J.W. reported that Central District has 11 member clubs with 454 members; Northeast District has 8 member clubs with 334 dancers; Northwest District has 23 member clubs with 733 dancers; St. Louis District has 25 member clubs with 1026 dancers; Southeast District has 4 member clubs with 86 members; Southwest District has 29 clubs with 1198 dancers, and West Central District has 17 member clubs with 482members. There are 117 clubs and 4313 dancers in Missouri. Ninety-six percent of the clubs have paid their 2003 dues.

Boundaries and Relations: Jim and Eloise Riley. No report. Constitution and Bylaws: Jim and Eloise Riley. No report. State Festival Site Screening: Jim & Eloise Riley. No report. Publications: Dave & Barb Turner. Discussed the practice of providing advertisers, who take out an annual advertisement, with a complimentary copy of the Doin s. Most publishers provide advertisers with a tear sheet rather than a complementary subscription to the publication in which the advertisement appears. Doyle Collins made a motion to refer this subject back to committee for their recommendation. Motion carried.

Caller/Cuer Hall Of Fame Committee: Barb and Dave Turner. One nomination has been received. All nominations must be in to the committee by Aug. 1st, 2003. Insurance: Floyd & Carolyn Herren. Beginning Balance - \$822.17. Income for April 2003 - \$73.40; Income for May 2003 - \$0; Expenses for April 2003 -\$70.70; Expenses for May 2003 - \$0; Balance on hand, June 01, 2003 - \$824.87. Enrollment in Plan A - 1162 members, 26 Clubs. Enrollment in Plan B - 2072 members, 38 Clubs plus 5 minimum clubs (67 - members).

Historian: Ray & Vicky Wittman. No report.

Blue Bird: Judy Epperson. No report.

License Plate: Linda Collins. Doyle Collins presented the report. Beginning Balance - \$861.49; Income - \$0; Expenses - \$14.32; Ending Balance - \$847.17.

Member Services: Randy and Juanita Boyles. No report.

**Dancer of the Year Award:** Don and Joann Miller. One nomination has been received. Packets for nominating Dancer of the Year were passed out at the last meeting. Everyone is encouraged to go back to their districts and solicit nominees from their clubs.

**Promotions:** Jim & Edythe Weber. There has been no activity with the "Let's Toot Our Horn" program since the last meeting.

The State Square Dancer pins have been received. The pins are .40 cents each. 500 have been sold to date. There are 25 per package. Anyone wanting to purchase a package can do so. An order blank is in the Doin s.

The committee recommends that Sept. 5, 2003, be recognized as Square Dance Day. All dancers are encouraged to wear their square dance attire to work, shop, and wherever they go on that day. Pass out flyers, answer questions about square dancing, do demonstrations, promote club lessons, or anything else to make square dancing visible and desirable. The motion carried.

**USD A Report:** Jim and Edythe Weber. A packet of credit card applications was passed out to each district president. USDA receives a royalty for each application approved, and each purchase made using the credit card. Fifty percent of the royalties are returned to the affiliates, and 25% goes to Handicapable dancing to fund their registration to either a National Convention or a Handicapable National Convention. Twenty-five percent goes to youth programs. Be sure that the prescription discount cards are distributed and their use encouraged. About 750 prescriptions are being filled each month by participants using this card. The USDA meeting will take place on Wednesday at the National Convention. William Sundwall will be receiving the USDA Founders Memorial Fund Scholarship for \$500.00.

**Editor:** Jim & Edythe Weber. Only three club articles were received after the deadline, May 28th cut-off. There is a new form for submitting articles to the Doin's. It also includes guidelines defining what is a special dance. Be sure to include the name of your club at the top of the club article. If the person submitting the club article is not the same as the club contact, place the name and phone number of the person submitting the article at the bottom of the article. Lessons can be listed in the dance calendar for the first 3 to 4 lessons that new students are being accepted. Nine sent them by regular mail and 60 sent them by e-mail.
