The guidelines for nomination, as set forth by the Missouri Federation Standing Rules are as follows:

1. Calls or cues for a club that is currently a member of the Missouri Federation.
2. Has been an active caller or cuer for a period of no less than 20 years.
3. Has participated in the annual state festival at least five times out of the most recent 10 years of active calling or cuing (the committee will verify the qualifications of the nominee).

Districts are not limited to one nomination per year. Callers or cuers who have been nominated previously and not selected may and should be nominated again. We will acknowledge receipt of your nomination so you know it has been received.
