<u>Treasurer's Report:</u> Read by Carol Morris. Copies of the financial report for the period of March 3, 2018 through May 18, 2018 were distributed. Beginning balance was <u>\$5341.95</u> with an ending balance of <u>\$4820.97</u>. Expenses included to Sharon White, Loretta Compton, & Carol Morris for state meeting of \$10.00 each. Bank charge of \$26.25 for new checks, to Shirley Winans for supplies of \$6.70, to Show Me Doins ad for District Festival of \$50.00, Show Me Doins Dance proceeds of \$499.00 (correction check voided for incorrect endorsement-\$499.00), to Hi-Hashers for rebate incentive of \$35.00, re-issue check to Show Me Doins for \$499.00.

Income of \$50.00 for March 3 meeting dance reimbursement. \$75.00 return of cleaning deposit for Doins Dance. Interest of \$0.50 & \$0.47. Correction of interest from last meeting reported \$.086, should have been \$.046. Carol Morris stands the report as written & to be audited by Mark Gentry.

<u>Missouri Federation:</u> Loretta Compton reported the State Meeting held in Moberly on April 22, 2018 had checking account balance \$7,372.25, total CDs is \$50,266.25 with total of \$57,638.50. Total subscriptions is 300, received 70 renewals, 4 new, & 5 went to new students.

Insurance reported that there are 49 clubs, 1,219 dancers insured, 335 dancers through other federations for total of 1,554 dancers.

Next meeting will be in Joplin on June 3, 2018 with the SW district host.

<u>2019 State Festival</u>: Report given by Catherine McLemore. Work in progress on obtaining funds for the State Festival. Ann Cook stated the 2018 design is finished & will be ordering shirts & sweatshirts. Colors of Caroline blue & silver. Looking for participants for several committees.
